**EMAU-Continental Judges Seminar**

Dear Presidents,

After the first seminar in 2005 the EMAU Judge Committee will organize in autumn 2007 a second training seminar for national judges who are interested to be examined for Continental Judges status. It will be limited to the candidates from the EMAU Member Associations.

The candidates for the status of Continental Judge must have been at least two years judge at the highest corresponding national level. The language will be English.

The seminar will be a joint seminar with FITA Judge Committee for Continental judges wishing to upgrade to the status of FITA Judge Candidate. Please inform your Continental Judges accordingly.

The seminar will take place at the Centro di Preparazione Olimpica Acqua Acetosa "Giulio Onesti" of the Italian National Olympic Committee (CONI), situated in the northern outskirts of Rome (Italy) with following schedule:

Tuesday, 23 October - arrival of participants,

Wednesday, 24 October – seminar sessions,

Thursday, 25 October – seminar sessions,

Friday, 26 October, until noon - exam.

The candidates can be lodged in the premises of the preparation centre. Only double rooms are available. The price, per person, full board, per day, for the duration of the seminar is 53 EUR. The candidates will bear all costs and expenses themselves. FITARCO will kindly organize pick-up transport from the two airports in Rome to the seminar venue.
